Minutes of the Rescheduled Regular Meeting of the Cape May County Library Commission held on Thursday, December 15, 2022 at 1:30pm, in the Board Room of the Cape May County Library in Cape May Court House, NJ.

- 1. Mrs. Henderson called the meeting to order and announced it was being held in accordance with the Open Public Meetings Act.
- 2. The minutes of the meeting of November 16, 2022 were presented for review and approval. Mr. Hutchinson made a motion to approve the minutes, which Mr. Mastrangelo seconded. The motion passed unanimously.

Orsini also reported that the Teen Department had 10 programs with 68 participants in November. Lastly, Orsini reported that the Adult Programming Department had 90 programs in October with 767 participants.
 - b. Orsini reported that Mrs. Henderson was reappointed for another term on the CMCLC.
 - c. Orsini presented the 2023 Preliminary Budget.
 - d. Resolution December 2022 #1, Advancement, was introduced. Mrs. Henderson made a motion to accept the resolution, which Mr. Mastrangelo seconded. The resolution passed unanimously.
 - e. Resolution December 2022 #2, Separations, was introduced. Mr. Mastrangelo made a motion to accept the resolution, which Mrs. Henderson seconded. The resolution passed unanimously.
